

Contract Agreement Form for the Procurement of Goods (Revised)
[Not required to be submitted with the Bid, but it shall be submitted within ten (10) days after receiving the Notice of Award]

CONTRACT AGREEMENT

THIS AGREEMENT made the ____ day of **APR 06 2021** between **BUREAU OF QUARANTINE, 25th A.C. Delgado Street Port Area Manila** of the Philippines (hereinafter called "the Entity") of the one part and **INFOCENTRIC SOLUTIONS INC. of 200 Canley Road, Bagong Ilog, Pasig City** (hereinafter called "the Supplier") of the other part;

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **Procurement of ICT Projects, Equipment, and Consumables under PB-2020-06** and has accepted a Bid by the Supplier for the supply of those goods and services for **One Million One Hundred Forty-One Thousand Two Hundred Fifty Pesos Only Php 1,141,250.00** (hereinafter called "the Contract Price").

NOW, THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as an integral part of this Agreement, viz.:
 - i. Philippine Bidding Documents (PBDs);
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract; and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted;

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to a request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conform thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. **The winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.**
3. In consideration for the sum of **One Million One Hundred Forty-One Thousand Two Hundred Fifty Pesos Only, Php 1,141,250.00** or such other sums as may be ascertained, **INFOCENTRIC SOLUTIONS INC.** agrees to perform the delivery of **Lot 1: Voice Cabling for Building 1 and 2; Lot 2: Antivirus** following his/her/its Bid.
