

Contract Agreement

THIS AGREEMENT made this _____ day of MAY 17 2021 between **BUREAU OF QUARANTINE, 25TH A.C. DELGADO STREETS, PORT AREA, MANILA** (hereinafter called the "Entity") and **GRAND SKY BUILDING CORPORATION, RIZAL STREET, BARANGAY II, DAGUPAN CITY, PANGASINAN.** (hereinafter called the "Contractor").

WHEREAS the Entity is desirous that the Contractor executes **PROPOSED BUREAU OF QUARANTINE OPERATIONS CENTER AT THE ROOF DECK OF PHYSICAL EXAMINATION BUILDING** under NP-EC-2021-03 (hereinafter called "the Works") and the Entity has accepted the Bid for **PHP 2,598,881.68, TWO MILLION FIVE HUNDRED NINETY-EIGHT THOUSAND EIGHT HUNDRED EIGHTY-ONE AND 68/100 PESOS ONLY** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW, THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as an integral part of this Agreement, to wit:
 - (a) Request for Quotation
 - (b) Drawings/Plans;
 - (c) Terms of Reference / Scope of Works
 - (d) Bill of Quantities
 - (e) Detailed Estimates
 - (f) Price Schedule;
 - (g) Schedule of Requirements;
 - (h) Eligibility requirements, documents, and/or statements;
 - (i) Notice of Award of Contract and the Bidders conform thereto;
 - (j) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
4. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
