

Contract Agreement

THIS AGREEMENT made this **DEC 09 2021** day of _____ between **BUREAU OF QUARANTINE, 25TH A.C. DELGADO STREETS, PORT AREA, MANILA** (hereinafter called the "Entity") and **C.B. GARAY PHILWIDE BUILDERS, 16 YAKAL WEST STREET, MARCOS HI-WAY, SANTOLAN, PASIG CITY** (hereinafter called the "Contractor").

WHEREAS the Entity is desirous that the Contractor executes **RENOVATION OF COLD CHAIN ROOM FOR VACCINES AT BOQ MAIN BUILDING, NP-EC-2021-39** (hereinafter called "the Works") and the Entity has accepted the Bid for **PHP 172,000.00, ONE HUNDRED SEVENTY TWO THOUSAND PESOS ONLY** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW, THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as an integral part of this Agreement, to wit:
 - (a) Request for Quotation
 - (b) Scope of Works
 - (c) Bill of Quantities
 - (d) Detailed Estimates
 - (e) Price Schedule;
 - (f) Schedule of Requirements;
 - (g) Eligibility requirements, documents, and/or statements;
 - (h) Notice of Award of Contract and the Bidders conform thereto;
 - (i) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
4. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.
