

Contract Agreement

THIS AGREEMENT made this DEC 13 2021 day of _____ between BUREAU OF QUARANTINE, 25TH A.C. DELGADO STREETS, PORT AREA, MANILA (hereinafter called the "Entity") and MERCEDEZ SHELL GASOLINE STATION, MCLL HI-WAY, MERCEDEZ, ZAMBOANGA CITY, ZAMBOANGA DEL SUR (hereinafter called the "Contractor").

WHEREAS the Entity is desirous that the Contractor executes **PROCUREMENT OF FLEET CARD FOR BOQ VEHICLES AND ZAMBOANGA LAUNCH FY 2021** under NP-TFB-2021-04 (hereinafter called "the Works") and the Entity has accepted the Bid for **PHP 795,960.00., SEVEN HUNDRED NINETY-FIVE THOUSAND NINE HUNDRED SIXTY PESOS ONLY** by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW, THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as an integral part of this Agreement, to wit:
 - (a) Request for Quotation
 - (b) Price Schedule;
 - (c) Schedule of Requirements;
 - (d) Technical Specifications;
 - (e) Eligibility requirements, documents, and/or statements;
 - (f) Notice of Award of Contract and the Bidders conform thereto;
 - (g) Other contract documents that may be required by existing laws and/or the Entity.
3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
4. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.


