

Contract Agreement

THIS AGREEMENT made this 14 JUN 2022 day of _____ between BUREAU OF QUARANTINE, 25TH A.C. DELGADO STREETS, PORT AREA, MANILA (hereinafter called the "Entity") and PAMINTUAN ENTERPRISES DAVAO INC. (APO VIEW HOTEL), J. CAMUS STREET, DAVAO (hereinafter called the "Contractor").

WHEREAS the Entity is desirous that the Contractor executes FOOD AND ACCOMMODATION FOR SEMINAR WORKSHOP FOR PERFORMANCE MANAGEMENT REVIEW IN DAVAO STATION under NP-SVP-2022-28 (hereinafter called "the Works") and the Entity has accepted the Bid for PHP 110,000.00, ONE HUNDRED TEN THOUSAND PESOS ONLY by the Contractor for the execution and completion of such Works and the remedying of any defects therein.

NOW, THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement, words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract hereinafter referred to.
2. The following documents shall be attached, deemed to form, and be read and construed as an integral part of this Agreement, to wit:
 - (a) *Request for Quotation*
 - (b) *Price Schedule;*
 - (c) *Schedule of Requirements;*
 - (d) *Eligibility requirements, documents, and/or statements;*
 - (e) *Notice of Award of Contract and the Bidders conform thereto;*
 - (f) *Other contract documents that may be required by existing laws and/or the Entity.*
3. In consideration of the payments to be made by the Entity to the Contractor as hereinafter mentioned, the Contractor hereby covenants with the Entity to execute and complete the Works and remedy any defects therein in conformity with the provisions of this Contract in all respects.
4. The Entity hereby covenants to pay the Contractor in consideration of the execution and completion of the Works and the remedying of defects wherein, the Contract Price or such other sum as may become payable under the provisions of this Contract at the times and in the manner prescribed by this Contract.

Mandate

The Bureau of Quarantine (BoQ) under the Department of Health (DOH), with the category of a first-class line bureau, shall have a nationwide scope of function and international commitment in accord with the International Health Regulations (IHR) of the World Health Organization (WHO).

The Bureau is authorized to promulgate rules and regulations (apprehension, detention or surveillance) as necessary to prevent the introduction, transmission or spread of "public health emergencies of international concern" (PHEIC) from foreign countries into the Philippines.

Jurisdiction and Functions of the Bureau

The examination at ports of entry and exit in the Philippines of incoming and outgoing vessels and aircraft,

The necessary surveillance over their sanitary conditions, as well as over their cargoes, passengers, crews, and all personal effects, and

The issuance of quarantine certificates, bills of health, or other equivalent documents shall be vested in and be conducted by the Bureau.

This Bureau shall have authority over incoming and outgoing vessels both domestic and foreign, including those of the army and navy, their wharfage and anchorage, and over aircraft and airports, insofar as it is necessary for the proper enforcement of the provisions of this Act.


