Invitation to Bid for Installation of Power Supply for BOQ Main 3-Storey Building

1. The *Bureau of Quarantine*, through the *General Appropriations Act 2022* intends to apply the sum of **One Million Seven Hundred Seventy-three Thousand Four Hundred Sixty-Three Pesos Only (Php 1,773,463.00)** being the Approved Budget for the Contract (ABC) to payments under the contract for **Installation of Power Supply for BOQ Main 3-Storey Building under PB-2022-16**. Bids received in excess of the ABC shall be automatically rejected at bid opening.
2. The *Bureau of Quarantine* now invites bids for the above Procurement Project. Completion of the Works is required **Forty-five (45) Calendar Days upon receipt of Notice to Proceed**. Bidders should have completed a contract similar to the Project. The description of an eligible bidder is contained in the Bidding Documents, particularly, in Section II (Instructions to Bidders).
3. Bidding will be conducted through open competitive bidding procedures using non-discretionary “*pass/fail*” criterion as specified in the 2016 revised Implementing Rules and Regulations (IRR) of Republic Act (RA) No. 9184.
4. Interested bidders may obtain further information from *Bureau of Quarantine* and inspect the Bidding Documents at the address given below from **Monday to Friday except Holidays, 8:00 AM – 5:00 PM**.
5. A complete set of Bidding Documents may be acquired by interested bidders on **November 24, 2022 to December 14, 2022** from given address and website/s below *and upon payment of the applicable fee for the Bidding Documents, pursuant to the latest Guidelines issued by the GPPB, in the amount of Five Thousand Pesos (Php 5,000.00)*. The Procuring Entity shall allow the bidder to present its proof of payment for the fees *in person*.
6. *Bureau of Quarantine* will hold a Pre-Bid Conference¹ on **December 02, 2022 at 01:30PM** at the **PE Conference Room, 2nd Floor PE Building, 25th and A.C Delgado Sts., Port Area Manila** and through videoconferencing/webcasting *via Cisco Webex Meetings*, which shall be open to prospective bidders. **Link shall be provided by the BAC Secretariat upon request prior to the said date.**
7. Bids must be duly received by the BAC Secretariat through manual submission at the office address as indicated below, on or before **01:30 PM, December 14, 2022**. Late bids shall not be accepted.

¹ May be deleted in case the ABC is less than One Million Pesos (PhP1,000,000) where the Procuring Entity may not hold a pre-bid conference.

8. All bids must be accompanied by a bid security in any of the acceptable forms and in the amount stated in **ITB** Clause 16.
9. Bid opening shall be on **01:30 PM, December 14, 2022** at the **PE Conference Room, 2nd Floor PE Building, 25th and A.C Delgado Sts., Port Area Manila** and **through Cisco Webex Meetings**. Bids will be opened in the presence of the bidders' representatives who choose to attend the activity. **Link shall be provided by the BAC Secretariat upon request prior to the said date.**
10. The **Bureau of Quarantine** reserves the right to reject any and all bids, declare a failure of bidding, or not award the contract at any time prior to contract award in accordance with Sections 35.6 and 41 of the 2016 revised Implementing Rules and Regulations (IRR) of RA No. 9184, without thereby incurring any liability to the affected bidder or bidders.
