

Contract Agreement Form for the Procurement of Goods (Revised)
[Not required to be submitted with the Bid, but it shall be submitted within ten (10) days after receiving the Notice of Award]

CONTRACT AGREEMENT

THIS AGREEMENT made the 11th day of April 2023 between **BUREAU OF QUARANTINE, 25TH A.C. DELGADO STREET PORT AREA MANILA** of the Philippines (hereinafter called "the Entity") of the one part and **GAPROTEC SECURITY INC. 2ND FLOOR ALBULARIO BUILDING, GEN. MAXILOM AVENUE, CEBU CITY** (hereinafter called "the Supplier") of the other part,

WHEREAS, the Entity invited Bids for certain goods and ancillary services, particularly **SECURITY SERVICES FOR BOQ CEBU AND KALIBO STATION under PB-2022-22**, and has accepted a Bid by the Supplier for the supply of those goods and services for **Two Million Thirty Thousand Nine Hundred Eighty-One Pesos and 28/100, Php 2,030,981.28** (hereinafter called "the Contract Price").

NOW, THIS AGREEMENT WITNESSETH AS FOLLOWS:

1. In this Agreement words and expressions shall have the same meanings as are respectively assigned to them in the Conditions of Contract referred to.
2. The following documents as required by the 2016 revised Implementing Rules and Regulations of Republic Act No. 9184 shall be deemed to form and be read and construed as an integral part of this Agreement, viz:
 - i. Philippine Bidding Documents (PBDs):
 - i. Schedule of Requirements;
 - ii. Technical Specifications;
 - iii. General and Special Conditions of Contract, and
 - iv. Supplemental or Bid Bulletins, if any
 - ii. Winning bidder's bid, including the Eligibility requirements, Technical and Financial Proposals, and all other documents or statements submitted,

Bid form, including all the documents/statements contained in the Bidder's bidding envelopes, as annexes, and all other documents submitted (e.g., Bidder's response to a request for clarifications on the bid), including corrections to the bid, if any, resulting from the Procuring Entity's bid evaluation;
 - iii. Performance Security;
 - iv. Notice of Award of Contract; and the Bidder's conform thereto; and
 - v. Other contract documents that may be required by existing laws and/or the Procuring Entity concerned in the PBDs. The winning bidder agrees that additional contract documents or information prescribed by the GPPB that are subsequently required for submission after the contract execution, such as the Notice to Proceed, Variation Orders, and Warranty Security, shall likewise form part of the Contract.

3. In consideration for the sum of **Two Million Thirty Thousand Nine Hundred Eighty-One Pesos and 28/100, Php 2,030,981.28** or such other sums as may be ascertained, **GAPROTEC SECURITY INC.** agrees to perform the delivery of **SECURITY SERVICES FOR BOQ CEBU AND KALIBO STATION** following his/her/its Bid.

Mandate

The Bureau of Quarantine (BQ) under the Department of Health (DOH) with the category of a first-class line bureau, shall have a nationwide scope of function and international commitment in accord with the International Health Regulations (IHR) of the World Health Organization (WHO).

The Bureau is authorized to promulgate rules and regulations (apprehension, detention or surveillance) as necessary to prevent the introduction, transmission or spread of "public health emergencies of international concern (PHEIC)" from foreign countries into the Philippines.

Jurisdiction and Functions of the Bureau

The examination at ports of entry and exit in the Philippines of incoming and outgoing vessels and aircraft.

The necessary surveillance over their sanitary conditions, as well as over their cargoes, passengers, crews and all personal effects, and

The issuance of quarantine certificates, bills of health or other equivalent documents shall be verified/issued by conducted by the Bureau.

This Bureau shall have authority over incoming and outgoing vessels, both domestic and foreign, including those of the army and navy, their wharves and anchorage, and over aircraft and airports, insofar as it is necessary for the proper enforcement of the provisions of this Act.


